RE: CONGRESSIONAL RESPONSE TO NOTICE OF TREASON

Dear Senator McConnell and Senator Schumer:

Subject: THE FINGER ON THE PROBLEM

So many have said that they do not even recognize the United States of America anymore, but many cannot quite put their finger on the problem. My family's case *is* the finger on the problem.^a

The United States is on the brink of another revolution. My son Josiah Robert Fornof, second witness to treason along with me, saw that and called attention to it in his letter dated May 17, 2008, which ends with Mr. Fornof's earnest plea, "Again: please help protect me and my people from the aforesaid rebellion," referring to the government's rebellion against the People:

Dear Congresswoman Brown-Waite:

Please help protect me and my people from this rebellion: Commencing and continuing contiguously from at least as far back as September 11, 1986, the governing bodies of these United States of America, top to bottom, across the board, federal, state, and local are inescapably in breach of contract with lethal

consequences against We the People, including against my grandparents Ruth Elvada Denniston Blevins and Robert Frank Blevins and theirs; said lethal consequences include but are in no manner limited to: the murder of my grandmother Ruth Elvada Denniston Blevins (1923-1997) and the in-progress murdering of my grandfather Robert Frank Blevins (1925-) by the aforesaid wrongdoers and their countless aiders and abettors who have also attempted to murder my mother Kimberly Ann Blevins (1956-), my aunt Constance B. Cieszynski (1947-) and me, Josiah Robert Fornof (1980-), and certain other of my grandmother's survivors. What is inescapably in place is a system that is not above the law, but that is more powerful than the law, and that wields said power unlawfully, lethally, genocidally, against me and my people, against We the People. The aforesaid is inescapably proven by Clerk of Courts Jed Pittman's response to my letter dated April 13, 2008 (see enclosures). Again: please help protect me and my people from the aforesaid rebellion, although it may be too late for me after May 19, 2008, if not sooner.

Soon after the Federal Bureau of Investigation (FBI) unlawfully arrested Mr. Fornof on August 19, 2010, at his request I attempted to acquire from Congressman Bilirakis a copy of the above-referenced letter from the congressman's files. After a substantial amount of corresponding with his staff, following is the outcome of that effort:

The only copy we have is what you sent us yesterday. The address listed on the letter was in the 5th district. If there was a secondary address, that was not included in what was sent. Additionally, the primary address is what defines congressional district. If we had kept a copy, it would have been up to 1 year as all documents are purged after 1 year for privacy reasons (including fax transmittal sheets).

I do not know how anyone, oath-bound to uphold the Constitution, does not respond lawfully to the fact that treason matters to everyone and is everyone's responsibility to address lawfully.

On May 29, 2008, 12:12 AM EDT, soon after that letter was delivered to the recipients, I wrote and published a blog post entitled, "All Dominions Shall Serve and Obey Him," which includes the following about a website hit we received from the Congressional Country Club:

Tonight, at 7:18:40 (PM), we had a web site hit from <u>ccclub.org</u>, hitting only one page: <u>LAWYER-LAW</u> <u>FIRM SUPPORTERS OF WILLIAM R. WEBB (1994, 2000)</u>, which includes the following:

Gus M. Bilirakis, Bilirakis Law Group, P.A., 4538 Bartelt Road, Holiday, FL 34690-5532, *Contributor to Webb's campaign in: 1994*

William R. "Bill" Webb is an attorney, including my parents' attorney (as of December 24, 1987, case open, his responsibility to settle lawfully and to my parents' satisfaction). On October 18, 1994, at a time when Bill Webb had been fraudulently elected judge but had not yet been likewise sworn in, he via another lawyer, then-Sheriff Lee Cannon, unlawfully terrorized his own clients, my parents, at their own home deep in their thickly wooded estate, and did so by stealth, trespass and with lethal (unlawful police) force and did so to enhance his being sworn in, unlawfully, fraudulently. What Webb did not that date represents just a microcosm of what he had been doing all along, and it continues. The law says that as to my parents and theirs, what Webb and his reciprocal aiders and abettors -- including Gus Bilirakis, but in no manner thus limited -- have done constitutes breach of contract, attempted murder, murder, genocide, and certainly more: the law identifies what it is, and my father and his side with the law.

Gus M. Bilirakis is the son of long-time former Congressman Mike Bilirakis (Tarpon Springs, Florida). At the

time he aided and abetted Webb in attempting to murder my parents, he was just a lawyer. Later, Bilirakis became a state representative, and then later still, a United States Congressman, a position he still occupies.

You will recall that in my May 18, 2008 blog <u>They Shall Take Away the Ashes... and Spread a Purple Cloth Over It</u> which includes Josiah's May 17, 2008 letter to Congresswoman Ginny Brown-Waite, with a courtesy copy to Congressman Gus M. Bilirakis. The State of Florida has unlawfully suspended Josiah's driver's license, and including thereby, has confirmed that they are, indeed, murdering Josiah and fully intend to keep doing so and have no intention of becoming lawful. That is beyond obscene!

The <u>ccclub.org</u> [IP Address <u>63.81.15.#</u> (Congressional Countr)] belongs to the <u>Congressional Country Club</u>, which I feel sure is so exclusive that only members of Congress (and their spouses or guests) may enter. I doubt even their staffers are allowed to go there as a matter of course.

The State of Florida has been attempting for decades to silence me by any means necessary even though I have written all that I have written in exercise of my constitutionally-guaranteed rights and my responsibility as a citizen. It is for writing such blog posts as the one above, for publishing such details as were included therein that the Pasco County Sheriff unlawfully arrested me on September 6, 2017, and that the State of Florida has had me under unlawful criminal prosecution¹.

My family and I desperately need relief from the aforesaid war. Mr. Fornof is living under the burden of expecting that his release from prison, which is scheduled for May 29, 2019, is going to end with him being riddled with bullets, and he has expressed that in that way as recently as yesterday in a couple of telephone conversations. I have included as an attachment the recording of the more recent of those, yesterday commencing at 2:24 PM EDT. The scripture passage that I mentioned therein that my father often cited is from Matthew:

Matthew 25:21-23 King James Version (KJV)

- 21 His lord said unto him, Well done, thou good and faithful servant: thou hast been faithful over a few things, I will make thee ruler over many things: enter thou into the joy of thy lord.
- 22 He also that had received two talents came and said, Lord, thou deliveredst unto me two talents: behold, I have gained two other talents beside them.
- 23 His lord said unto him, Well done, good and faithful servant; thou hast been faithful over a few things, I will make thee ruler over many things: enter thou into the joy of thy lord.

In *DC vs. Heller*, Justice Antonin Scalia wrote some things about the danger that the forefathers saw in a standing army, and we do well to discern how the People are being surrounded on every side by such armies on top of such armies as local law enforcement becomes militarized, and as my family and I have experienced, allow themselves to be weaponized against the People. The Sheriff is



part of the state judicial branch. "We fight as one" is the PCSO motto. That is most terrifying, given the reign of terror under which my family and I have been forced to live, September 11, 1986 to date, and in which the PCSO has had no small part.

I expect to write you separately to provide a selected timeline of evidence from January 7, 2009 through August 19, 2010 that proves that on July 6, 2009, when the Sheriff trespassed against my family and me, they intended to murder us all and that said order figures to have come straight from the White House. We recorded the Sheriff's trespass and then published the recording on YouTube and later on Mr. Fornof's website.^b My December 28, 2017 letter to the Attorney General of Florida includes:

They all latched on to a civil matter that never should have come to that as a smokescreen and a cover up for their own wrongdoing, and they kept boring in until they could falsely claim under color-of-law that it had become criminal as to me, and they are doing that to silence me as a witness and to make an example of me as a silenced witness.

Another pretrial conference has been scheduled for Tuesday, October 16, 2018 in the State's unlawful criminal prosecution of me. What does the Constitution guarantee that I may do in regard to that specifically? What happens if I assert that right to the fullest? Why is this war allowed to continue against my family and me? When and how does it end? With all of us riddled with bullets?
