Kimberly Ann Blevins v. United States, State of Florida, Pasco County Sheriff Chris Nocco, et al

Dear Sheriff Nocco:

Effective immediately, and continuing as long as there is a need, correct yourself and others on any and all absurd and false assertions that my family and I ever have been involved in or currently are involved in any domestic terrorist activities or groups, including Sovereign Citizens.

That lie, that my family and I are domestic terrorists, specifically Sovereign Citizens, was sown to create a stigma about us and to distract from the fact that we are witnesses to treason committed by and through individuals operating within the United States governing bodies, in other words the enemy invading and occupying such positions, top to bottom, across the board, federal, state, local, including but in no manner limited to within and through the Pasco County Sheriff's Office, commencing and continuing contiguously from at least as far back as September 11, 1986.

About 10 years ago, the PCSO participated on a counterterrorism task force with the Federal Bureau of Investigation (FBI) and others which investigated my son Josiah Robert Fornof and me as to whether we have any connections to domestic terrorists, specifically to Sovereign Citizens, a group we never even heard of until that false allegation came to our attention. The FBI's conclusion is documented in a report dated 01/06/2011 which includes about me and my son Josiah Robert Fornof, "Moreover, the Tampa Division has determined that neither [my name is redacted on the copy I have] nor FORNOF are associated with any Domestic Terrorism groups." That includes, of course, Sovereign Citizens.

Given that, how is it that well over a year and nine months after said report, you via your deputy continued to falsely claim that my home is a "known Sovereign Citizen encampment" and to make other false allegations along those lines, in an official PCSO report, OCA 12-049597, Reporting Officer Daniel J. Stewart, dated 09/15/2012, that is part of the discovery in the State of Florida's unlawful case against me? How is it that said false claim against my family and me continues to crop up in various and sundry places, as recently as yesterday?

The ongoing stigmatizing of my family and me, including as described above, is consistent with harassment and more, and serves to further the aforesaid treason, meaning that every instance of such false claim against us is in itself an overt act of treason (see August 17, 2010 recorded telephone conversation among Kimberly Blevins, Josiah Fornof, the FBI and others).

Therefore, effective immediately, and continuing as long as there is a need, correct yourself and others on any and all absurd and false assertions that my family and I ever have been involved in or currently are involved in any domestic terrorist activities or groups, including Sovereign Citizens; which could be considered as further harassment, stigmatizing, and however else it works to injure us, including in furthering treason etc. against us if you fail to correct yourself and others on this important fact. We are just an American family, trying hard to survive in the face of the war that certain individuals, including in the PCSO, have been waging against us for a very long time, nearly 33 years so far.

The law (F.S. 876.33 and 18 U.S. Code § 2382. Misprision of treason) requires me to report that I have knowledge of treason "as soon as may be" to identified authorities who I copied herein in order to comply with that law: I do have knowledge of yet more overt acts of treason, committed again yesterday, including as described above in continuing acts of such.
