Subject: GROSSLY OVERDUE PUBLIC RECORDS REQUEST

The University of South Florida (USF) is grossly overdue in providing me with an item I requested via a public records request I submitted on March 16, 2017; namely:

A copy of the fraudulent claim in USF police records that on or about January 27, 1995 my father Robert F. Blevins brought a gun to the swearing in ceremony of my father and mother's lawyer William R. Webb, husband of Mary Webb, USF faculty member and any and all other USF documentation that references said specific claim. I need to know the identity or identities of the person or persons who made that claim and what effort USF made to verify whether said claim is true, which as indicated it is not and I can prove it.

USF used that lie to destroy my family and our constitutionally-guaranteed rights, my promising career being one of the casualties of USF's levying war against my family and me, against the United States, and lies being but one of USF's weapons of choice. I have a right and a need to the records I have requested. To date, USF holds said item hostage in furtherance of treason. That is serious, for each person, including for you personally!

In treason there are no accessories; all who engage in the rebellion at any stage of its existence, or who designedly give to it any species of aid and comfort, in whatever part of the country they may be, stand on the same platform; they are all principals in the commission of the crime; they are all levying war against the United States." [United States v. Greathouse et al., 26 F. Cas. 18, Case No. 15,254 (October 17, 1863): FIELD, Circuit Justice (charging jury).]

USF must provide me with the records I have requested forwith, and at no cost to me.

To the aforesaid, I add another public records request: for any and all records showing that in 2000 to 2001 USF responded lawfully to the notice of treason that I gave to USF (e.g. as Dr. Genshaft was required to do so under 18 U.S. Code § 2382. Misprision of treason and Florida Statute 876.33). Via my hand-delivered, written correspondence dated July 14, 2000, I let Dr. Genshaft know that I have knowledge of the commission of treason against the United States, thus conveying that knowledge to her. Provide me with whatever proof exists that Dr. Genshaft disclosed her thus-acquired knowledge of the commission of treason against the United States "as soon as may be" to "the President or to some judge of the United States, or to the governor or to some judge or justice of a particular State. . ." If no such proof exists in USF's records, provide me with a signed statement to that effect.

The matter is and always has been treason, and the fact that my family and I are on the We the People side that does not consent to ruling by treason and neither do we consent to being so ruled, by treason. To date, USF has proven to be on the anti-We-the-People side that consents to ruling by treason and to being so ruled, by treason, and it remains to be seen whether the university will be any different during your tenure than it has been during the entirety of your predecessor's tenure.
