You do not state why you do not have a copy of the items my mother requested. As my mother stated, my letter was sent to you via Certified Mail, Return Receipt Requested. My letter was co-signed by her and by Nathan A. Fornof, as additional witnesses and victims of the crimes that we complained to you about, and the return receipt shows that our letter was delivered to you/your agent on July 7, 2010.

The crimes outlined in our complaint were not exhaustive, but were an attempt to open a conversation with law enforcement to talk about other crimes that the acts disclosed to you might constitute, such as obstruction of justice, misprision of treason, and treason. That is all as I discussed in my August 17, 2010, recorded telephone conversation with the Joint Terrorism Task Force (JTTF), which included such agencies as the Federal Bureau of Investigation (FBI), Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), the Pasco County Sheriff's Office (PCSO), and others. The aforesaid telephone conversation constitutes substantial and competent evidence in any lawful investigation about my concerns, as expressed therein, and as expressed herein, in this letter.

Now you say that you do not have a copy, but I do. Attached is the copy (without signatures) that my mother emailed to her sister, my aunt Constance Jane Cieszynski (1947-2017) on July 6, 2010. My letter starts, "This is an official complaint against Bob White, Sheriff, Pasco County, Florida.", and by that letter, I gave you notice of crimes committed against my family and me by and through the Pasco County Sheriff and others on July 6, 2009: that notice has never been followed up with any lawful investigation, thus compounding my well-founded fears of how that could be and who in those positions of trust and government are behind it all, and of why I need to arm myself, including with firearms, to defend myself, my family, and my fellow citizens from such clear and present danger by a domestic enemy.

Your letter dated December 3, 2019, arrived on December 6, 2019, the same day that you forced my mother Kimberly Ann Blevins, under lethal threat, to appear yet again in court, this time for a status check in the unconstitutional case that you, via your agent Stefen Diskey, are unlawfully prosecuting against her

at your and his own peril and have been allowed to do such particularly because our attempts to initiate lawful investigation into our grave concerns have been obstructed, allowing you and yours to come on the unlawful attack against us, including with unconstitutional applications of the law as in the in-progress case *State of Florida v. Kimberly Ann Blevins*, Case No. 512017CF004974CFAXWS, AGGRAVATED STALKING-FOLLOW HARASS CYBERSTALK AFTER INJUNCTION. You have had fair notice all along to know that my mother's blog posts do not meet the "directed at a specific person" element of the stalking/cyberstalking statute, including as defined in the statute itself and case law, including but not limited to the following cases:

*Reno v. American Civil Liberties Union*, 521 US 844 - Supreme Court 1997 (e.g. at 869).

*Chevaldina v. R.K./FL Mgmt., Inc.*, 133 So. 3d 1086, 1092 (Fla. 3d DCA 2014) (reversing injunction against cyberstalking for internet posts).

*Horowitz v. Horowitz*, 160 So. 3d 530 - Fla: Dist. Court of Appeals, 2nd Dist. 2015 (reversing injunction because posts were not directed at a specific person).

*David v. Textor*, 189 So. 3d 871 - Fla: Dist. Court of Appeals, 4th Dist. 2016.

All of those cases, as well as others, were well in place before you falsely charged my mother with stalking, which itself meets the elements of your stalking – i.e. following and harassing -- against her and her family, which includes myself; indeed, your failing to lawfully respond to my concerns of subject letter and coming on the further unlawful attack against us with such unconstitutional application of the law is consistent with your harassing me and my family in multiple instances.

The evidence against you continues to mount, as in the following recent case, which cites some of the above cases and holds to the finding in all of them that information posted on the Internet to be read by the public does not meet the "directed at a specific person" element of Florida Statute 784.048, and my concerns I have communicated to you and to your office include that there are individuals in positions of government that are levying war against us, which includes their harassing and stalking us. (Given the context of the aforesaid letter and telephone conversation).

*Logue v. Book*, Fla: Dist. Court of Appeals, 4th Dist. 2019, which cites and holds to earlier rulings (see: B. "A Course of Conduct Directed at a Specific Person").

Nothing about my mother's conduct meets *any* of the elements of the offense of stalking or cyberstalking, but your and others' conduct do, and you all, via whatever agents, have had fair notice to know that, including through such case law as cited above, which is not by any means an exhaustive list. But, without any competent and substantial evidence against my mother, you relentlessly harass her and us anyway.


Your conduct meets all of the elements of the offense of aggravated stalking and many other offenses, including but not limited to Florida Statute 876.35 Combination against part of the people of the state., and Florida Statute 843.0855 Criminal actions under color of law or through use of simulated legal process. Harassment is also a natural consequence and element of those crimes.

By saying you do not have a copy of my letter, you are saying that you do not have a lawful response to my concerns that I have submitted to you and are harassing me with such an unlawful response. I

Failure on your part to follow up with a lawful response is subject to all of the lawful consequences of such dereliction of official and personal duty.

This is an official complaint against Bob White, Sheriff, Pasco County, Florida.

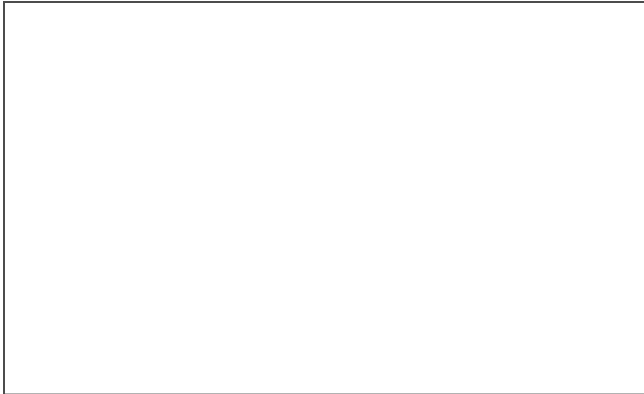
On July 6, 2009, at or about 4:05 PM, two Pasco County Sheriff deputies, unauthorized [i], entered, armed and wearing bullet-proof vests, into and upon enclosed land [ii] at 18060 Owen Drive, Hudson, Florida 34667-6659, and then did commit aggravated assault on me, Josiah R. Fornof, and on my brother, Nathan A. Fornof, and on my mother Kimberly A. Blevins [iii] [iv], and unlawfully dumped paper [v] [vi] upon leaving. To start, I refer you to "Sheriff Trespass" video, accessible on the enclosed compact disk (CD), and also accessible on YouTube at <http://www.youtube.com/watch?v=TAcwXt1-hso>

Note that my letter dated January 7, 2009, to The President, which was part of the packet of information given to the deputies on July 6, 2009, includes the following prophetic words:

In keeping with the aforesaid, you and your agents, aiders and abettors have well indicated that you are not just failing to get lawful, but have no intention of doing so *ever*: in failing to get lawful, you continue to come against me unlawfully and

perpetuate your unlawful, criminal, genocidal onslaught against my grandparents and theirs, against me, against We the People, against any and all lawful entities!

Indeed, on July 6, 2009, The President of the United States, via Pasco County Sheriff Bob White, was caught red-handed on video carrying through just as I had predicted some six months earlier.



What are our rights as victims in the aforesaid? What can we lawfully expect from the State? What does the State lawfully expect from us? Your answering these questions, via registered mail, over your own signature, may be taken as an act of good faith. Your continuing failure to do your official duty on these matters is evidence that the State of Florida willfully intends to further come unlawfully against me, against my family, against the lawful authority, against We

the People. This is another attempt among many to protect myself and my family and to resolve these issues peacefully, by due process.
