RE: JOSIAH ROBERT FORNOF UNLAWFUL INCARCERATION

As of August 19, 2010, my son Josiah Robert Fornof has been unlawfully incarcerated by the United States Department of Justice (USDOJ). Both he and I have previously informed you in writing of the actual controversy which is our family's case, through which we testify as follows:

Commencing and continuing contiguously from at least as far back as September 11, 1986, the governing bodies of the United States of America, top to bottom, across the board, federal, state, local, and their reciprocal benefactors aiders and abettors, including but in no manner limited to the State of Florida and the United States Department of Justice (USDOJ) have waged war against its own citizens, including but in no manner limited to: my parents Ruth Elvada Denniston Blevins (born August 31, 1923, in Denniston, Kentucky-died January 11, 1997, in Hudson, Florida) and Robert Frank Blevins (born March 13, 1925, in Blevins Valley, Kentucky-died November 10, 2011, in Hudson, Florida) and theirs, including me Kimberly Ann Blevins (born April 17, 1956 in Middletown, Ohio-) and mine, and others. Said warfare includes holding us all under reign of genocide and treason, through decades, across generations of our family. The death of each of my parents and my sister Constance B. "Connie" Cieszynski (born September 17, 1947, in Middletown, Ohio-died May 19, 2017, in Trinity, Florida) confirm that each has been murdered by said governing bodies et al. The murdering of my parents' survivors, including of my son Josiah R. Fornof (born July 17, 1980, in New Port Richey, Florida), and me, and others by the aforesaid entities continues with no end in sight.

This letter is one of several in regard to the aforesaid as well as to follow up Josiah's dated August 29, 2016, to you and to President Barack Obama with the subject line "Treason." My purpose in writing this and the others is to prepare for Josiah's release from his unlawful incarceration and successful reentry into society and to effect prosecution of the treason through which Josiah was incarcerated and war otherwise has been waged against my parents and theirs continuously, contiguously, from at least as far back as September 11, 1986, and it was apparently lying in wait as of that time.

Where does the lawlessness, the war against us end, Governor Scott? I would really like to know the answer to that question.

Josiah has asked me to apprise you of certain details of his unlawful incarceration, not simply for your information, but so that you will activate whatever you must to protect him from federal encroachment.

The Bureau of Prisons (BOP) literature includes that the time to start preparing for release is the first day of incarceration. Josiah has done so without fail; however, neither the Court nor the BOP nor any other entity to whom he and we have appealed will lawfully address our grievances, indicating quite convincingly that when Josiah is released from prison, it will be right back into the war which was the reason that he armed himself in the first place.

As a family, we have addressed these matters peacefully for *decades* now and across three generations of our family. Throughout we have been, as my late father Robert Frank Blevins said, as sheep led to the slaughter. Is it going to take literal bloodshed to activate lawful process, or would it even happen then? From what we have seen, it would be just more cover up, a lie for example that Josiah has committed suicide by cop, and not that he lawfully armed himself to defend himself and others against wrongdoing, tyranny oppression by and through the government itself, something that our forefathers saw as a real potential and made provision for stopping, except those provisions are not being respected by the government.

While Josiah was at Coleman Medium Federal Correctional Institution here in Florida, he set in motion processes within the prison system to address his concerns. Their answer was to put Josiah into a SHU (Special Housing Unit) cut off from communicating with his family and then to ship him out, first to distant Oklahoma City, and then to Yazoo City, where he spent the next years.

The same scenario prevailed at Yazoo City, where Josiah had procedures in motion to help him prepare for release (Attachment 7) and before those processes could finish, and in order to cover up their wrongdoing and continue to do more of the same (and worse) they moved Josiah, four times in one month no less: to Oklahoma City, then to Atlanta, then to Tallahassee, and then to Jesup. Now, at Jesup, from the outset the prison staff has proven to be hard-wired against Josiah, without lawful excuse, and once again they have him in the SHU for "investigatory detention" with the net effect that again Josiah is cut off from communicating with loved ones and recognizes that they are doing what they can to push him to the breaking point.

Josiah has sent me a series of briefs of his interactions with staff at Jesup and has directed and informed me as follows:

Please scan these briefs and transcribe them into a cleaner format, to send to our Honorable Governor, Rick Scot [sic], FL.; in addition to our other info.

I had to re-write all of these briefs, to provide you with these courtesy copies of them, and I will have to re-write this letter to you for my copy of it. So, naturally, my hand is worn raw. It feels like what arthritis would be like, if I had it.

This war against us manifested when Josiah was just a little child of six years old, and he has grown up under that ongoing terror thereof: the mental, emotional, physical, and practical effects of that war stand as hard evidence of the ravages of that war and hence serve as same as to the reality of that war. I have done as Josiah directed me, and transcribed each brief and scanned the originals for your ready reference. The transcriptions have only minor edits. Each brief is numbered as follows, as I have numbered them, and are labeled as Josiah has labeled them:

- 1. Attachment 1: Fornof, J.R. (2017, Jul. 8) brief of interactions with officers Hawkinsmith and Caesar (cf. Sisson).
- 2. Attachment 2: Fornof, J.R. (2017, Jul. 8) brief of interactions with Counselor King.
- 3. Attachment 3: Fornof, J.R. (2017, Jul. 8) brief of interactions with psychology staff, Coffman.
- 4. Attachment 4: Fornof, J.R. (2017, Jul. 8) brief of interactions with SIS Best.
- 5. Attachment 5: Fornof, J.R. (2017, Jul. 8) brief of interactions with Case Manager Buggs.
- 6. Attachment 6: Fornof, J.R. (2017, Jul. 8) brief of interactions with SIS Best and warden, FSL.

Attachment 7, as indicated above, is a copy of the packet of Josiah's emailed correspondence to staff while he was in Yazoo City, pertaining to Josiah's attempts to prepare for his release and re-entry into society. I have merged these into one 47-page attachment. These serve as documentation of the process that Josiah lawfully and peacefully initiated, the same processes that the BOP is unlawfully obstructing.

We are having issues with our mail getting through, including our certified and first class mail, and including to you. Mail dated July 8, 2017, that Josiah sent to me, containing those briefs, did not reach me until August 3, 2017. While Josiah is in investigatory detention in the prison, he is only allowed one 15-minute call home every 30 days. He last called on August 1, 2017, at 8:22 PM. Toward the end of that call, we discussed what Josiah has and does not have, including that he does not have *four boxes* of his legal materials from Yazoo City which were supposed to be moved with him, and we also discussed what I had and had not yet received, including that I had not yet received the briefs Josiah painstakingly wrote out *twice* by hand, as indicated above.

Josiah said, "In that one, I gave you instructions to send it to the Governor, so they're holding up an investigation." I told him about funny stuff going on with our mail. Josiah said, "There's an administration that was in effect before my unlawful arrest on this case..." and that the unlawful arrest "was trying to prevent people who are able to do something about it lawfully in our favor from getting the information, and that's part of the warfare that's waged against us."

Activate whatever process you must to get Josiah released from his unlawful incarceration and returned back home and equipped in all ways to work with me and others to effectively prosecute treason and more, as the law, the real law and ruling out color of law, requires of us as citizens of the United States of America and of the State of Florida.
