RE: CONGRESSIONAL RESPONSE TO NOTICE OF TREASON

Dear Chairman Gowdy and Chairman Goodlatte:

The enclosed new flash drive contains a copy of my April 6, 2018, letter and related exhibits, which I previously emailed to both Committees at the email address provided to me by staff of the Oversight Committee. Some of those exhibits were lengthy and did not transmit via email, which is the reason that I am following up by sending them to you by flash drive. Today I requested staff to provide me with the case number that Congress has assigned to my complaint and supporting documentation so that I can reference same on my future correspondence going forward but I did not receive that number in time to include on this letter.

Said letter to your Committees includes the following on the first page:

This letter constitutes my notice to Congress that I have knowledge of the commission of Treason. I have written this letter to you at the behest of my son Josiah Robert Fornof who on August 17, 2010, gave notice of Treason to the Federal Bureau of Investigation (FBI): the FBI fails to date to investigate said Treason, and instead covers up and furthers same. Josiah's notice to the FBI relates directly to Congressional investigations into President Trump and Russia

Years ago, one of the FBI's own advised me that each Special Agent in Charge (SAIC) of each FBI field office reports, in effect, to the President of the United States (POTUS). Thus, in regard to the entirety of that unlawful and treasonous FBI investigation into my family and me, the SAIC of the Tampa field office was reporting directly to President Barack Obama. Therefore, the statement above should be understood as follows:

This letter constitutes my notice to Congress that I have knowledge of the commission of Treason. I have written this letter to you at the behest of my son Josiah Robert Fornof who on August 17, 2010, gave notice of Treason to <u>President Obama via</u> the Federal Bureau of Investigation (FBI): the FBI fails to date to investigate said Treason, and instead covers up and furthers same. Josiah's notice to the FBI relates directly to Congressional investigations into President Trump and Russia.

The Tampa FBI SAIC was and still is obliged to accurately and truthfully convey Josiah's notice of treason to President Obama. When President Obama was preparing to leave office, he was obliged to do the same with incoming President Trump. Did any of that happen? If not, where did the process first break down, and why?

Page 10 of my April 6, 2018, letter to your Committees includes:

Compel the FBI to expedite my FOIPA Request No. 1362193-002 for a copy of the unedited audio recording and the transcript of the afore- and hereinafter-mentioned August 17, 2010, telephone conversation. My family and I need that evidence to defend ourselves against the FBI's continuing to levy war against us

Via email, I plan to provide you with more detail and documentation about that FOIPA request that will aid you in your Congressional Investigation, but there is nothing that should delay your Congressional Inquiry and compliance with my above demand to compel the FBI to expedite my request.
