RE: CONGRESSIONAL RESPONSE TO NOTICE OF TREASON

Dear Committee Member:

Subject: FOIPA REQUEST NO. 1362193-002

My above-referenced Freedom of Information and Privacy Act (FOIPA) request is for an unedited transcript and audio recording of the telephone conversation of nearly three hours that my son Josiah Robert Fornof had with the Federal Bureau of Investigation (FBI) whereby Josiah gave notice consistent with 18 U.S. Code § 2382 – Misprision of Treason to President Barack Obama via the FBI, as I have discussed in previous correspondence to you, most recently in my April 18, 2018, letter which includes:

Page 10 of my April 6, 2018, letter to your Committees includes:

Compel the FBI to expedite my FOIPA Request No. 1362193-002 for a copy of the unedited audio recording and the transcript of the afore- and hereinafter-mentioned August 17, 2010, telephone conversation. My family and I need that evidence to defend ourselves against the FBI's continuing to levy war against us

Via email, I plan to provide you with more detail and documentation about that FOIPA request that will aid you in your Congressional Investigation, but there is nothing that should delay your Congressional Inquiry and compliance with my above demand to compel the FBI to expedite my request.

The purpose of this letter and exhibits is to follow through on that commitment.

The FBI has assigned my request to a complex track which they say can take two years more or less to fulfill. The FBI denied my request to expedite, whereupon I appealed that decision with the Office of Information Policy (OIP) which upheld the FBI's denial to expedite my request. I then

resubmitted my request to expedite to the OIP by pointing out that said FOIPA request is inextricably tied with another which is still in progress. That one is for information about the employment of Paul Meissner, Jr., with the FBI. I mentioned his name, his *surname*, in my letter dated April 20, 2018, to you, on Page 3. That request to the OIP is still pending, well past the 1/29/2018 due date. Following is my most recent correspondence to the OIP regarding the aforesaid:

My various requests to expedite FOIPA No. 1362193-002 are at a complete standstill and I am being stonewalled along at least three different tracks: 1) my January 15, 2018, appeal to the OIP, discussed above; 2) my October 29, 2017, offer to the FBI, RIDS office to simplify my request in order to move it from a complex track to a faster-moving track; and 3) my January 15, 2018, request for mediation services from the Office of Government Information Services (OGIS), National Archives and Records Administration, OGIS Case No. 18-01170.

When I spoke with Mr. O'Neill about expediting my request because the public needs to know, he said that in order to do that, I would need to be a member of some recognized media outlet or someone whose position it is to get the word out to the public. I told him that I am a blogger. He

said that if my blog was very widely read, then that could be a consideration, but otherwise not. I found such reasoning flawed in the extreme, and that conversation is the basis for what I included on Page 3 of my above-referenced letter to him:

Mr. O'Neill, I take direct responsibility for my own obligation *as a citizen* to inform my fellow Americans of what is going on, what I know not in general terms or as hearsay only, but from decades of personal experience, and I do not accept nor entertain for so much as a moment any notion by anyone that I have delegated that obligation to the media. Quite the contrary: the media has an obligation toward me and toward all other of my fellow citizens to publish my account, yet across decades now of seeking help from the media, they have failed miserably and have identified that they, too, are part of the vast network of lawless ones that I have referred to above.

In regard to the State of Florida's unlawful, genocidal, treasonous prosecution of me relative to Case No. 2017CF004974CFAXWS, SECTION 4, I sent an urgent plea for help from my courtappointed lawyer in acquiring FOIPA No. 1362193-002 for my defense.

As indicated, my letter was sent Priority Mail, Certified Mail, Return Receipt Requested. Tracking confirms that said item was delivered, yet, I still have not received the return receipt, and that has become a pattern relative to at least three items of correspondence so far, related to the State's above-referenced unlawful prosecution of me. Those are:

- 1. Certified Mail No. 7015 1730 0001 2988 7072, for my March 14, 2018, letter to my lawyer referenced above, which was delivered on 03/15/2018 at 10:42:00; however, I never received the associated return receipt No. 9590940231577166037389.
- 2. Certified Mail No. 7015 1730 0001 2988 7089, for my March 30, 2018, letters to my lawyer (see hereinafter) which was delivered on 04/02/2018 at 11:14:00; however, I never received the associated return receipt No. 9590940231577166037372
- 3. Certified No. 7009 3410 0001 3823 0618, for my April 18, 2018, courtesy copy to Sheriff Chris Nocco, of my letter to Judge Kimberly Ann Campbell; already there is a USPS® Delivery Exception for the associated return receipt No. 9590940231577166037358, a notice that I received while writing this letter.

My April 18, 2018, letter to Judge Campbell is critically important, as is the courtesy copy to Sheriff Nocco; that is why I paid for the postal service that I did for both.

Notice that includes my two letters dated March 30, 2018, both of which I sent under the same Certified Mail number referenced above. The subject of one letter is, "Yet Another Death in the Family," and the subject of the other is, "Treason and Misprision of Treason (Follow Up)."

Problems with our mail, including our certified mail service is nothing new, and in fact has been going on for decades. In 2002, in court, I offered a table outlining about six mail pieces I had attempted to mail to the Court in that case via Certified Mail, Return Receipt Requested, and that about half of them had not gone through. The judge said it sounded like I had a problem with my post office. I replied that it was *three different post offices*. My son Josiah has just sent me a letter outlining such problems that he has had while in prison.

Genocide, remember, is *systematic*. Here, I am reminded of something that my father Robert Frank Blevins included in his telltale letter of some 40 pages dated December 7, 1997, to the U.S. Department of Justice (emphasis added):

On October 15, 1996 at 4:48 AM, glaring lights began to be played on the front of our dwelling, and were clearly visible from our bedroom albeit we had not one, but double thick, shades closed, and brilliant shafts of light came through the edges of the shades! The foregoing continued until 5:01 AM, and was accompanied by a voice and/or voices and an alternate violent rattling of our front door and of the very window of our bedroom where Ruth lay on her deathbed. One of his Deputies, advised me that we were most likely listed as troublemakers, meaning that they were to cause us trouble any time they could. That was most enlightening.

Indeed, across the decades as I have been struggling to raise my children, work full time, go to school full time, and deal with the normal stresses of life, I have been unlawfully harassed no end as there has been no end to the extra stresses piled on in countless ways that in and of themselves may not constitute crimes, but when seen as what they are, part of systematic genocide and treason, they are that. By keeping me under chronic stress, and excess cortisol production, they hope to kill me. Even my one-time pastor, his wife, their family and church and denomination want me dead and act like it. That is pretty bad, but the State loves it because the State wants me dead for sure.

On Wednesday and Thursday last week, I spent a good bit of my time going from one post office to another, trying to track down the return receipt. The Aripeka Post Office sent me to the one in New Port Richey, which sent me to the one in Trinity, which sent me to the one in Hudson. One

post office supervisor told me that they see this a lot with mail going to 34654 zip code, and more specifically, to the Courthouse, the West Pasco Judicial Center. She said often what happens is the postal delivery person does not bother to tear off the return receipt, but lets the mail go through with that intact, delivering the receipt to the addressee. I said this is *legal mail*, and I need that proof for my protection. She said she knew and shrugged as if to say what could she do.

That is another way of saying, "What can *one person* do?" Thus, the genocide-committing system gains momentum and compounds because of such thinking and acting. Said system has made an example out of my family and me as to what happens when one person or one family dares to speak up and speak out and simply demand that people who are paid by the public remember who they work for and do their jobs, as I have demanded of Congress, including by my request, restated for emphasis:

Compel the FBI to expedite my FOIPA Request No. 1362193-002 for a copy of the unedited audio recording and the transcript of the afore- and hereinafter-mentioned August 17, 2010, telephone conversation. My family and I need that evidence to defend ourselves against the FBI's continuing to levy war against us.

Every citizen's rights and responsibilities go hand in hand. Deprive a citizen of their ability to act on their responsibilities to the best of their ability, and you also deprive them and others of their rights. Either we are *E Pluribus Unum* as a nation and we act like it, or we are not and should stop pretending that we are that. "Out of many, one" has a corollary: "Out of one, many," for everyone's voice matters to the whole. Remove all of the shackles that have been unlawfully placed on me and which are hindering my ability to fulfill my own obligations as a citizen, as a public servant, and as a true prophet of God Most High. Do likewise for every descendant of my beloved parents Ruth Elvada Denniston Blevins (1923-1997) and Robert Frank Blevins (1925-2011). We are a good family, and we deserve to live as we have always desired to live, in peace.
